## **PAYMENT OPTIONS:**

### **ANNUAL PAYMENTS**

Annual payments should be paid in full by 31<sup>st</sup> January each year to qualify for the 5% discount. (To qualify for this discount the compulsory levy must also be paid in full)..

### **MONTHLY PAYMENTS**

- ❖ All parents **must** sign a debit authorisation if they elect to pay monthly.
- ❖ Per month in advance payable before the 7<sup>th</sup> day of each month.
- ❖ Fees, including the development levy are collected over an 11 month period only (January to November).
- ❖ A sibling discount is granted as follows: 1<sup>st</sup> child 100% of the fee, 2<sup>nd</sup> child 95% of the fee, 3<sup>rd</sup> child 90% of the fee.
- ❖ All other tuition fees will be charged for separately.
- ❖ These fees include extramural tuition (from Gr 1 – Gr 12). Individual coaching is optional and for parents' own account.
- ❖ Registration fees Gr 000 – Gr 12: R4 500-00 (non-refundable).
- ❖ Waiting list deposit R1 000-00 [to be deducted from registration fees upon placement (non-refundable)].
- ❖ Registration fees for Boarding House Gr 8 – Gr 12: R2 500-00 (non-refundable).
- ❖ Development levy - the following developmental levy is compulsory and applicable for 2017:
  - Gr 000 – Gr 0: R81-00 x 11 months
  - Gr 1 – Gr 12: R172-00 x 11 months
