PAYMENT OPTIONS:

ANNUAL PAYMENTS

Annual payments should be paid in full by **31st December** each year to qualify for the **8%** discount and by the **31st January** to qualify for the **5%** discount. (This must include the compulsory printing and IT levy).

MONTHLY PAYMENTS

- ❖ Per month in advance payable before the 7th day of each month.
- ❖ Fees, including the printing and IT levy are collected over an 11 month period only (January to November).
- ❖ A sibling discount will be deducted i.e. 1st child 100% of the fee, 2nd child 95% of the fee, 3rd child 90% of the fee, 4th child 85% of the fee.
- ❖ All other tuition fees will be charged for separately.
- ❖ These fees include extramural tuition (from Gr 1 – Gr 12). Individual coaching is optional and for parents' account.
- ❖ Enrolment fees Gr 000 – Gr 12: R5 000-00 (non-refundable).
- ❖ Waiting list deposit R1 000-00 [to be deducted from enrolment fees upon placement (non-refundable)].
- ❖ Enrolment fees for Boarding House Gr 8 – Gr 12: R3 000-00 (non-refundable).
- ❖ Printing and IT Levy - the following printing and IT levy is compulsory and applicable for 2018:
 - Gr 000 – Gr 0: R82-00 x 11 months
 - Gr 1 – Gr 12: R182-00 x 11 months
